It's Time to Exempt No-Contest Clause Enforcement Proceedings from the Reach of the Anti-SLAPP Statute

Consider the following scenario: A beneficiary has filed a will contest alleging undue influence and lack of capacity. The will contains a nocontest clause. The proposed executor files a petition to disinherit the beneficiary because the proposed executor claims the beneficiary lacked probable cause to bring the contest. The beneficiary responds to the petition to disinherit by filing a special motion to strike under California's anti-SLAPP statue. Given the definition of the strategic lawsuit against public participation ("SLAPP"), the petition to disinherit will almost certainly be deemed a SLAPP.

Meg Lodise and Katherine McKeon Affirm Sanctions Order of More Than \$75,000 in a Conservatorship Action

In April 2016, a two-year battle came to an end after Partner **Meg Lodise** and Associate **Katherine McKeon** argued in support of an award of sanctions in a conservatorship case before the Second District Court of Appeal, and the appellate court affirmed the sanctions order. Lodise and McKeon represented the respondent defending against imposition of a conservatorship in 2014, and filed a motion seeking to dismiss the conservatorship petition on the grounds that it was improperly filed to gain leverage in a pending family law case, and for sanctions.

The conservatorship action was dismissed, and the Court then granted the motion, awarding the full amount of the requested fees, which totaled more than \$75,000. The petitioners appealed the sanctions order, McKeon argued before the Second District Court of Appeal, and in April 2016, the order was affirmed.
